

**Information on the conduct of the electronic Pre-Posting of the cadastral data for your properties belonging to the Municipalities of Andros, Anafi, Thira, Ios, Sikinos, Folegandros, Kea, Kythnos, Milos, Serifos, Mykonos, Amorgos, Naxos & Small Cyclades, Antiparos, Paros and Tinos.**

We inform you that from **24/09/2024** to **07/11/2024** the **electronic Pre-Posting** of the cadastral database will take place on the [ktimatologio.gr](http://ktimatologio.gr) website, for the following Pre-Kapodistrian Local Authorities per Kallikratic Municipality of the Regional Unit **Thira, Paros, Milos, Mykonos, Tinos, Andros, Kea-Kythnos and Naxos of the South Aegean Region.**

which includes the result of the processing of the declarations of Law 2308/95 submitted and the information collected in the context of the cadastral registration until **17-05-2024**.

*By using your personal taxisnet security codes, you can access the details of your rights and the respective properties and verify their correctness.*

**If you agree** with these data, there is no need to take any further action.

**If you do not agree** with any of these elements you have the right to submit, FREE OF CHARGE, a data review request EXCLUSIVELY within the above-mentioned deadline, via the link <https://www.ktimatologio.gr/e-services/4>, by clicking the LOGIN button at the top of the page, via TAXIS codes, attaching the relevant documents supporting the request. Alternatively, the application can be submitted to the relevant Cadastral Survey offices and for your best service it is suggested that an appointment be arranged beforehand (if more than 10 rights are to be registered).

In the case of properties that you have declared but are not included in the electronic Pre-Posting, your rights were either not established or the information you provided was deemed insufficient. You should contact the Cadastral Survey Office (see call center contact details) within the above

deadline in order to be instructed on your actions so that your rights are included in the temporary cadastral tables of the Posting.

In the event that the cadastral base of the Pre-posting **contains data on rights concerning you, for which you have not submitted a declaration**, but which resulted from the processing of other data collected, you should contact the Cadastral Survey Office within the above deadline (see call center contact details) in order to provide you with instructions for your actions, so that your rights can be included in the provisional cadastral tables of the **Posting**. For these rights, as long as you continue to be a beneficiary, **you must submit a declaration of ownership of Law 2308/95, paying the required fixed cadastral survey fee**, either by appointment at the relevant Cadastral Survey Office (see Office Addresses below), or digitally, via the website [www.ktimatologio.gr](http://www.ktimatologio.gr), through the "Electronic Services - e-KTIMATOLOGIO" application.

In the case that you have declared but **have not paid the required fixed cadastral survey fee**, please contact the competent Cadastral Survey Office (see contact details of the call centre), in order to be instructed on your actions to proceed to the immediate payment of the above debt to the cooperating banks. Once the aforementioned fee has been paid, you will be able, using your taxisnet codes, to access the details of your rights and their corresponding properties on the website [www.ktimatologio.gr](http://www.ktimatologio.gr) and verify their correctness.

After the completion of the Pre-Posting, the examination of the requests for review of data that will be submitted and the updating of the cadastral tables, the process of Posting will follow in a subsequent period of time.

Your participation in the Pre-Posting process is extremely important as it ensures that the rights you have declared will be correctly recorded in the Land Registry and you will avoid unnecessary hassle in the future..
